EMERGENCY ORDINANCE NO. 2023-04

AN ORDINANCE APPROVING THE CODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF ENON, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Enon, Ohio; and

WHEREAS, numerous sections in the Traffic and General Offenses Codes need to be amended or enacted in order to comply with State law;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Municipality of Enon, Ohio as follows:

SECTION I. The following sections of the Traffic and General Offenses Codes, as amended, are hereby approved and adopted as amended or enacted so as to conform to the enactments of the Ohio General Assembly:





Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

SECTION III. Council declares this to be an emergency ordinance necessary for the preservation of the public peace, health, safety, welfare and morals, such emergency arising out of the necessity to update the Village Traffic and General Offenses Codes to comply with the State law, wherefore this ordinance shall take effect and be in force from and after its passage and approval by the Mayor.
